2010 OZAUKEE IDOL COMPETITION

Official Rules

Eligibility:

- ★ Age 14 (by Jan. 1st of the current calendar year) and older. No maximum age.
- ★ Any contestant under the age of 18 must have a legal guardian accompany them to the competition. A legal guardian must sign the application form giving permission for their minor to perform.
- ★ To register as a contestant for Ozaukee Idol you must completely fill out an application form and mail it to: Ozaukee Idol, P.O. Box 173, Cedarburg, WI 53012. Applications MUST be postmarked by July 24th, 2010.
- ★ No members of the Ozaukee Idol Committee or their immediate family members will be eligible to participate in the Ozaukee Idol Competition.
- ★ Contestants must be an Ozaukee County resident OR have an Ozaukee County mailing address OR attend an Ozaukee County school OR have an Ozaukee county 4-H affiliation.
- ★ All contestants must be available for pictures and media coverage
- ★ All contestants must be available to perform at the preliminaries on Tuesday night, July 27th at 6 pm at the County Fairgrounds. Finalists must perform on Sunday, Aug. 1st at 1 pm at the County Fairgrounds. Contestants must arrive ½ hour prior to the start time.
- ★ A maximum of 20 competitors will be allowed. The first 20 applications received postmarked by due date will be notified by phone of their eligibility for competition.
- ★ Contestants are responsible for any copyright infringements.

The Performance Requirements:

- ★ All contestants must dress in attire suitable for a family audience.
- ★ Lyrics, gestures and performance must be suitable for a family audience.
- ★ Contestants must sing *a cappella* (without music or instrumental accompaniment) OR with music on a CD **without** lyrics. No lip syncing. Bring your own music CD for each song selected. You are not required to sing the same song at the preliminaries as at the finals.
- ★ Each contestant will have the following amount of time to sing:

Preliminaries / 5 minutes Finals / 5 minutes

Schedule:

- ★ Preliminary Round—Tuesday, July 27th at 6 pm at Centre Stage on the Oz. Cty Fairgrounds
- ★ Final Round—Sunday, August 1st at 1pm at Centre Stage on the Ozaukee Cty. Fairground
- ★ Winners will be selected and announced on stage .

Judging:

- ★ Each round will be moderated by a pre-selected panel of judges.
- ★ Judges will determine which contestants continue on to the final round.
- ★ At the final round, the judges will determine the three winning contestants.
- ★ The decision of the judges is final.

Prizes: First Prize / \$400 Second Prize / \$200 Third Prize / \$100

Disqualifications:

- ★ We reserve the right to disqualify and / or exclude any individual before, during or after competition for any reason.
- ★ Violation of any portion of these rules will result in disqualification and the competitor will be exempt from any prizes.
